Tripivor is an AI travel companion and itinerary-planning service. It helps users create personalized travel plans and discover travel options. During the current beta, Tripivor does not sell, issue, fulfil or confirm travel reservations and does not collect payment for third-party travel services.

3. Independent Travel Providers

Tripivor may provide links to independent third-party services, including Booking.com, Skyscanner, Hotels.com, Uber and other travel providers. Any reservation, purchase, payment, cancellation, refund or post-booking support is governed by the relevant third-party provider's terms. Unless expressly stated otherwise, Tripivor is not a party to the travel-service contract concluded between the user and the provider.

4. AI Transparency

Tripivor uses artificial intelligence to generate or assist with travel recommendations, itineraries and related content. Users are interacting with an AI-enabled service, not a human travel agent.
